INTERESTS AND APPROVE BIDDING PROCEDURES**

Please take notice that on August 1, 2025, Philip J. Montoya, Trustee, through counsel, filed the Trustee’s *Motion to Employ Bentley & Associates, LLC as Auctioneer for Trustee and for Authority to Conduct Auction of Property of the Estate Free and Clear of Liens, Claims or Interests and Approve Bidding Procedures* (“**Motion**”) in which Trustee asks the court to allow him to employ Bentley & Associates, LLC (“**Auctioneer**”) to sell the following vehicles (collectively hereafter “**Vehicle**”):

- a. 2022 GMC Sierra 2500; VIN 1GT39ME78NF357740
- b. 2022 GMC Sierra 2500; VIN 1GT39ME74NF315906

Auction wherein online bidding will open on www.bentleysauction.com at 10:00 a.m. MST on Thursday August 22, 2025, and all bidding will begin to close at 5:00 p.m. MST on Monday, September 3, 2025, or at the time listed on the website. The auction is Online only. Auctioneer’s compensation will be 10% of the auction gross proceeds, plus an estimated maximum of \$5,000.00 for costs and expenses such as advertising, transportation, and labor in preparation for sale. Further, Trustee seeks authority to sell

the Vehicles free and clear of liens, claims and interest, with those liens, claims and interests attaching to the proceeds with the same validity, priority and effect with which they attach to the Vehicles. Both Vehicles are encumbered by liens in favor of Alley Bank Corp. (“Ally”) which has stipulated to the sale, a copy of which stipulation was filed on May 20, 2025 at DE 82. If an objection is timely filed, a hearing (accelerated will be requested) to consider it will be held with (accelerated/shortened as allowed) notice to the attorney for the Trustee and any objecting party. If no objections are timely filed, an order granting the requests in the Application will be presented to the Court for entry without a hearing or further notice.
